1. Introduction

- 1.1 The Call for Sites provides landowners, developers and other stakeholders the opportunity to submit potential sites for development to the District Council. The Call for Sites is an important part of the evidence base which supports the development of the Council's Local Plan and provides information on where potential sites for development may be located.
- 1.2 This schedule has been prepared following the Call for Sites which took place between 29 January and 25 March 2024.
- 2.3 There will be further opportunities for stakeholders to submit sites through this process and throughout the preparation of the Council's new Local Plan.
- 2.4 **For clarity, the inclusion of a site in this schedule does not indicate that it will be successfully allocated or successfully obtain planning permission for development.**

2. Submission of sites

- 2.1 The Council undertook the Call for Sites in early 2024 as the first stage of its new Local Plan. Stakeholders were asked to complete a Call for Sites form on the council's website and provide a plan detailing the extent of the site along with any additional information.
- 2.2 In total 140 sites were submitted to the council as part of this process by 25 March 2024. Of these sites 110 had previously been submitted to the council with 30 new sites being submitted. Most of the sites submitted were for possible residential development, although sites have also been submitted for employment and commercial uses. Where site submissions have been made which alter previously submitted sites this latest information will be used by the Council.
- 2.3 Sites which have been submitted previously but were not resubmitted through this process will still be considered through the new local plan process. This schedule presents only those sites which were submitted during the Call for Sites 2024.

3. How this schedule will be used

- 3.1 This schedule reflects the submissions made through the Call for Sites consultation held between January and March 2024. **The inclusion of a site in this schedule does not indicate that it will be successfully allocated or successfully obtain planning permission for development.**
- 3.2 This schedule will be used along with our other evidence on land availability as part of the evidence supporting the progression of the new Local Plan. This document does not assess or determine whether any of the sites submitted should be allocated or developed. It is to be used as a simple record of those sites which have been submitted by stakeholders to be considered further through the local plan process.
- 3.3 Sites included within this schedule will be assessed through our land availability assessments which are produced on an annual basis.

4. Schedule of sites

- 4.1 Table 1 details all sites submitted through the Call for Sites by 25 March 2024. This includes a site reference number, the size of the site, suggested use and whether this was a new submission.

The inclusion of a site in this schedule does not indicate that it will be successfully allocated or successfully obtain planning permission for development.

- 4.2 Sites can be viewed using our [online interactive map](#). The following paragraphs explain how you can use our interactive map to view the sites which have been submitted. Several maps showing the location of all sites submitted across the district are included at [Appendix A](#) of this schedule.

Using the online map

- 4.3 When viewing the [interactive map](#) you can use the search function located in the top left of the map to search for a street or postcode. This can be used to locate sites which have been submitted in a particular area. Alternatively, you can navigate around the map manually in the same way you would any online map service.
- 4.4 Each submitted site is labelled with a reference number which can be used to find details about the site within this schedule. Alternatively, you can click on a site, this will bring up an information box which will tell you the name of the site, its reference number, the use which has been suggested for the site, the size of the site in hectares and the approximate level of development be that the number of homes or amount employment floorspace which has been suggested. You can view the maps key by clicking the icon in the top right corner of the map.

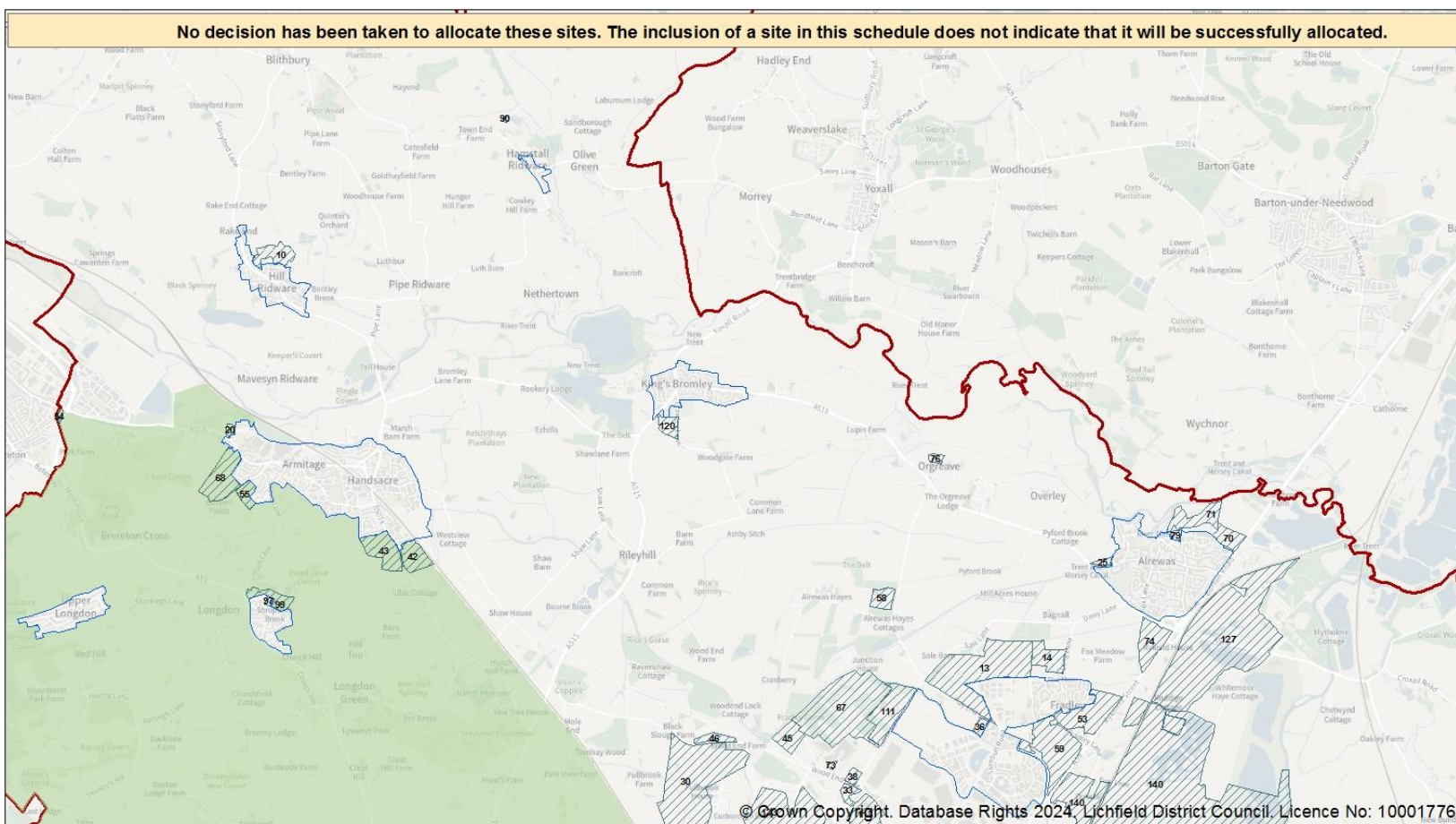

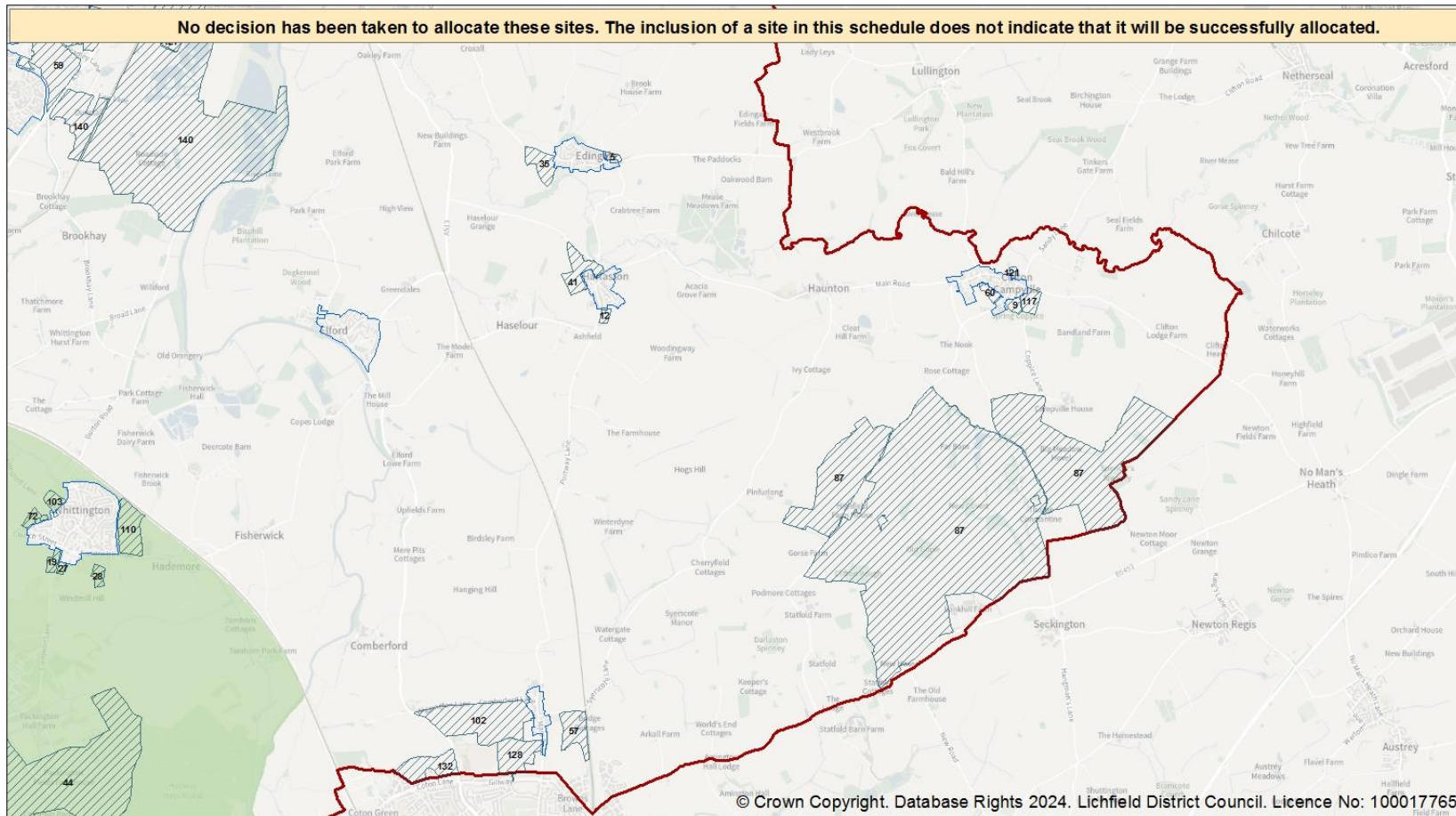


Call for Sites 2024: North of District

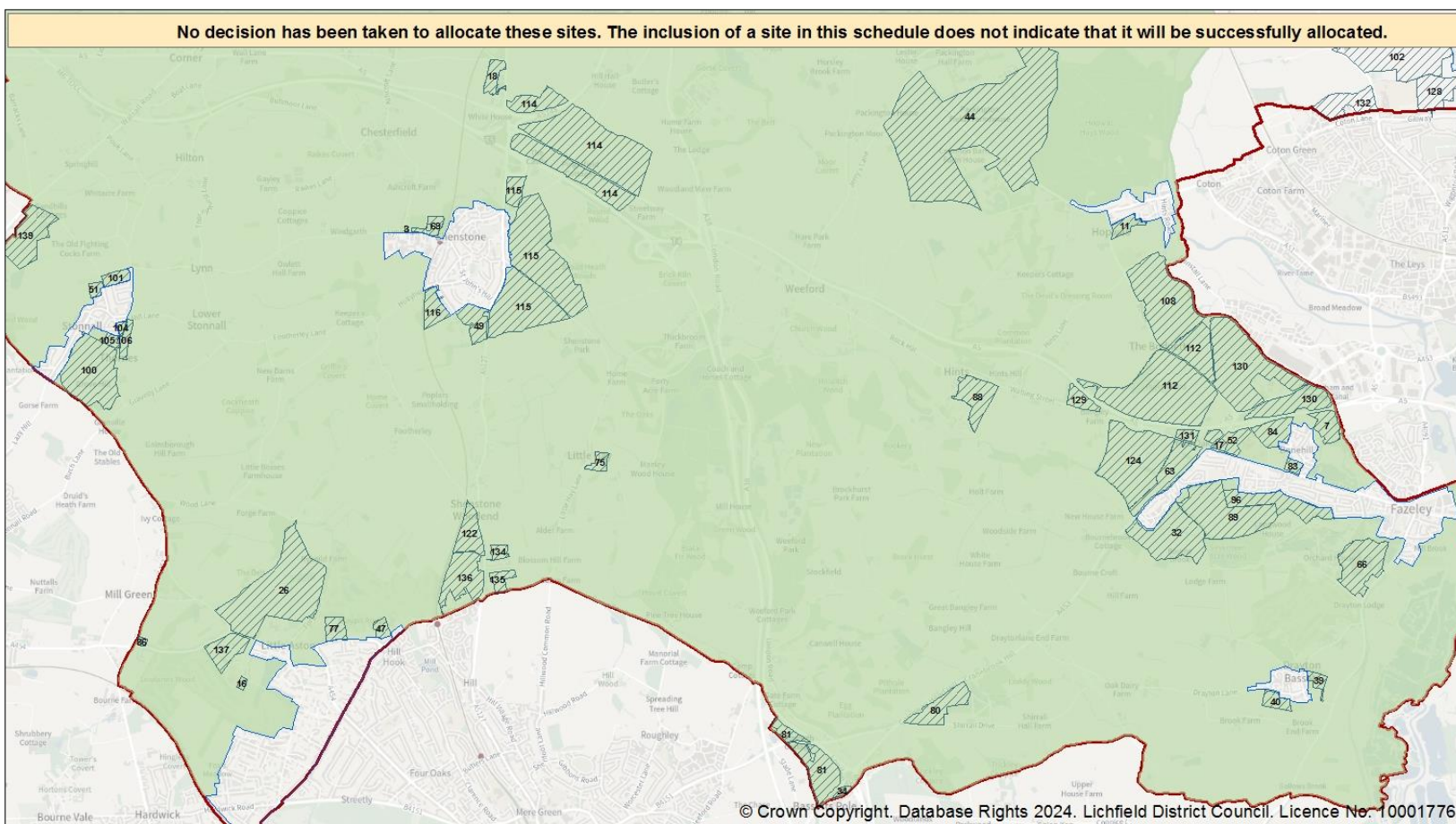

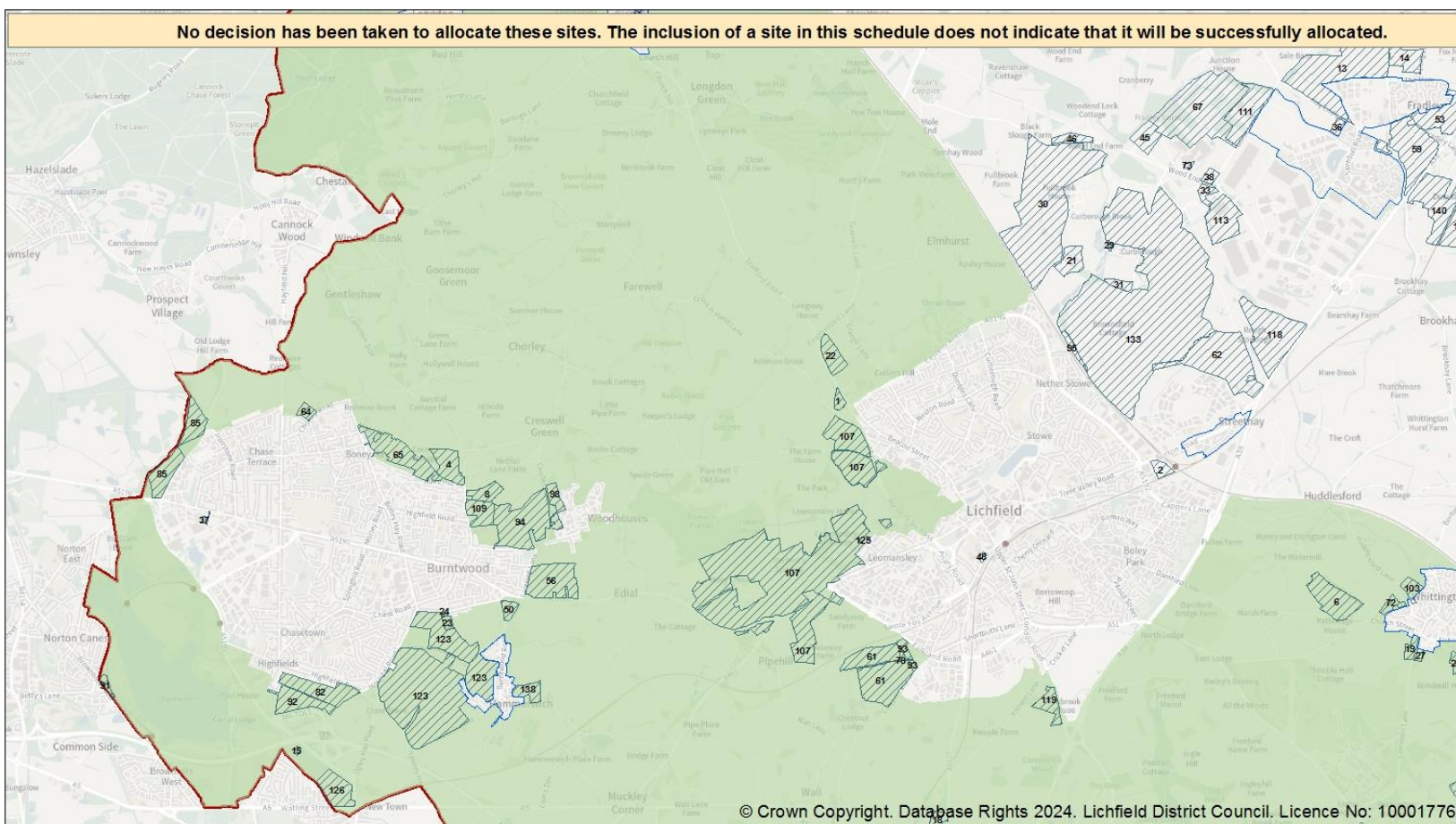


Call for Sites 2024: South of District
