Delegated to the Regulation & Enforcement Manager

A1	To discharge Lichfield District Council's duties, responsibilities and functions as local authority, council, district council, enforcement authority, waste collection authority, building authority, waste regulation authority, principal litter authority, licensing authority, food authority, local housing authority, hazardous substances authority, and local planning authority in relation to Regulation & Enforcement functions.
A2	To appoint officers and authorise them to use powers contained in the Acts listed at Annex A in relation to Regulation & Enforcement functions.
A3	To authorise the laying of information on behalf of the Council to prosecute for offences in relation to Regulation & Enforcement functions.
A4	To authorise and administer a caution on behalf of the Council as an alternative to prosecution for offences under the Acts listed at Annex A in relation to Regulation & Enforcement functions.
A5	To fulfil the role of an inspector or superintendent in relation to the Police and Criminal Evidence Act 1984.
A6	To fulfil the role of designated senior officer under the Investigatory Powers Act 2016 in relation to communications data.
A7	To fulfil the role of an authorising officer in relation to the Regulation of Investigatory Powers Act 2000.
A8	To approve and refuse applications for licences, permits, registrations, approvals and consents in relation to Regulation & Enforcement functions.
A9	To authorise officers to approve and refuse applications for licences, permits, registrations, approvals and consents in relation to Regulation & Enforcement functions.
A10	To authorise suitably competent officers to drive vehicles that are seized, forfeited or surrendered and taken into the custody of the Council following the execution of a warrant or order, or in accordance with powers contained in an Act listed at Annex A.
A11	To make arrangements for dealing with stray dogs in accordance with the Environmental Protection Act 1990 and to authorise suitably competent officers to handle and seize dogs.
A12	To authorise suitably competent officers to implant dogs with microchips via hypodermic needle.
A13	To authorise suitably competent officers to determine the type of a dog in accordance with the Dangerous Dogs Act 1991.
A14	To make arrangements for the care of animals taken into possession by an officer under the Animal Welfare Act 2006.
A15	To authorise that an animal be destroyed under the Environmental Protection Act 1990 or the Animal Welfare Act 2006.
A16	To make arrangements for the taking of steps as may be necessary to secure so far as practicable that the district is kept free from rats and mice in accordance with the Prevention of Damage by Pests Act 1949.
A17	To authorise suitably competent officers to use approved air weapons to kill rodent and avian pests.
A18	To make arrangements for the burial or cremation of the body of any person who has died or been found dead in the area, in any case where it appears that no suitable arrangements for the disposal of the body have been or are being made in accordance with the Public Health (Control of Disease) Act 1984.
A19	To appoint a lead food officer to perform food safety functions.
A20	To appoint a veterinary surgeon to perform animal welfare functions.
A21	To authorise officers to approve the execution of works in default of a notice served under an Act listed at Annex A in relation to Regulation & Enforcement functions.



A22	To authorise officers to approve the application for a warrant or order from a justice of the peace under the Acts listed at Annex A in relation to Regulation & Enforcement functions.
A23	To authorise officers to restrict the use of powers by an officer in their team in circumstances where they require further training or development.
A24	Unless prohibited by law or statutory guidance, to appoint a suitable deputy to undertake these functions during periods of absence.
