## 1. Introduction

1.1 The Infrastructure Funding Statement (IFS) provides a summary of the financial and nonfinancial developer contributions, also known as planning obligations, sought and received for the provision of infrastructure by Lichfield District Council. Lichfield District Council seek such obligations through the Community Infrastructure Levy (CIL) and Section 106 agreements (S106). Both S106 agreements and CIL are used to provide for supporting infrastructure associated with new development and maximise the benefits and opportunities arising from sustainable growth.

## Community Infrastructure Levy (CIL)

1.2 CIL is a charge on development intended to provide a funding stream for infrastructure needed to support the policies and proposals in the <u>adopted Local Plan</u>. CIL is used to fund the provision of a range of infrastructure that is needed to support the future growth of the district. Lichfield District Council began CIL charging on 13 June 2016 in accordance with its <u>adopted charging schedule</u>. The levy applies to specific development areas including residential within the open market, supermarkets, convenience retail and retail warehousing.

## Section 106

- 1.3 Section 106 of the Town and Country Planning Act (1990) enables local authorities to enter into a negotiated agreement (a planning obligation) to mitigate the impact of a specific development to make it acceptable in planning terms and the requirement of planning policy are met. S106 agreements can include direct provision of physical infrastructure or financial contributions toward the same. For example, S106 obligations can include:
  - Site-specific financial contributions these are secured and must be used for defined purposes; for instance, the provision of education facilities, traffic and transport/highways related works, open space contributions and affordable housing contributions (where accepted in lieu of on-site provision);
  - Provision of on-site affordable housing; and
  - Non-financial obligations, including requirements such as employment and skills strategies, construction management plans and travel plans.

## Format of the Infrastructure Funding Statement

- 1.4 The IFS will report upon the following key areas:
  - S106 and CIL payments sought and received within the preceding reporting period 1 April 2023 to 31 March 2024. This will also include information where expenditure or funds have been allocated to infrastructure projects within the reporting period and
  - The infrastructure projects or the types of infrastructure which the authority intends to wholly or partly fund via S106 or CIL in future reporting periods.

- 1.5 All authorities that receive S106 developer contributions or CIL payments are required to publish an Infrastructure Funding Statement (IFS) by the 31 December of each year to cover the preceding reporting period (1 April to 31 March) on an annual basis.
- 1.6 This is the IFS for Lichfield district for the period 1 April 2023 to 31 March 2024. <u>Section 2</u> and <u>Section 3</u> of this statement report upon progress in the collection and spending of CIL and S106 respectively. <u>Section 4</u> of the IFS looks forward and details planned expenditure over the next reporting period (2023/24).
- 1.7 Staffordshire County Council is also responsible for the provision of infrastructure and collects developer contributions from development within Lichfield district. As a contribution receiving authority the County Council prepare their own IFS which is <u>available</u> <u>online</u>.

## Key headlines

- 1.8 The following section provides the key headlines of this IFS. Further detail can be found in the relevant sections of this report. <u>Section 2</u> reports upon CIL, <u>Section 3</u> upon S106 obligations and <u>Section 4</u> looks forward to the types of infrastructure which it is intended will be funded in future years.
- 1.9 In 2023/24, the headline figures were as follows:

#### Community Infrastructure Levy (CIL)

- 1.10 Since the adoption of CIL in April 2016 and the commencement of charging on 13 June 2016 a total of £4,492,350.24 has been received to 31 March 2024.
- 1.11 The total CIL receipts collected for the financial year 2023/24 were £472,671.29. Of this:
  - £109,753.83 of receipts were collected from CIL and distributed to parish and town councils within the district to fund local infrastructure projects (The 'meaningful proportion')
  - £4,933.65 was collected to support Special Areas of Conservation (SACs) and
  - £23,633.56 was received and allocated towards meeting the administrative costs of the CIL charging regime per CIL Regulation 61.

#### Section 106 agreements

- 1.12 A total of £1,586,982.41 was received by the District Council via S106 obligations for the 2023/24 reporting year mostly towards delivering open space, community facilities and contributions towards the mitigation of development on the Cannock Chase SAC.
- 1.13 In 2024/2025, CIL and S106 expenditure will be focused on the following priorities, which are set out in greater detail at section 4 of this document:
  - Health provision

- Transport infrastructure
- Environment and biodiversity
- Low carbon initiatives

# 2. Community Infrastructure Levy

- 2.1 Lichfield District Council adopted its <u>CIL Charging Schedule</u> on 19 April 2016 and commenced charging from the 13 June that year. The amount of CIL liable is dependent on where the development is located within the district, the type of use proposed, the amount of floor space that is being created and the amount of existing floor space that is being lost<sup>1</sup>. The rate of CIL payable to an authority from a new development is both mandatory and non-negotiable<sup>2</sup>
- 2.2 The adopted CIL Charging Schedule sets out the charging rates for specific types of development and includes a map which illustrates the charging zones within the district. The charging schedule can be <u>viewed online</u>.
- 2.3 Since the adoption of CIL and the commencement of charging, £4,492,350.24 has been received up to 31 March 2023. Of this total, £472,671.29 was collected in the 2023/24 reporting year.
- 2.4 The following table shows the total CIL receipts received since charging (13 June 2016 to 31 March 2024)

## CIL income 2023-24 and headline figures

- 2.5 £472,671.29 of CIL receipts were collected in 2023/24. Of this:
  - £339,283.90 was collected in 2023/24 for spending on strategic infrastructure.
  - £0 was allocated for spending on strategic infrastructure within the reporting year

- £4,933.65 was collected for the Special Areas of Conservation (SACs)<sup>3</sup>
- £23,633.56 was received during 2023/24 for administrative expenses, as per CIL Regulation 61
- £109,753.83 of Neighbourhood CIL was collected (see Table 2.4). CIL Regulation 59D requires that these monies (the meaningful proportion) are allocated to their respective Town or Parish Councils.

#### **CIL** expenditure

- 2.6 Table 2.2 sets out the total CIL monies received and spent since charging began in June 2016. In accordance with Regulation 62 of the CIL Regulations 2010 (as amended) between the period of 1 April 2023 and 31 March 2024 Lichfield District Council as the CIL Charging Authority collected a total of £472,671.29 in CIL receipts. The total CIL expenditure for the period 1 April 2023 to 31 March 2024 is as follows:
  - £2,681.84<sup>4</sup> of Cannock Chase SAC CIL funds was transferred to those bodies responsible for the projects which seek to mitigate the harm on the SAC from development
  - £149,683.11<sup>5</sup> has been transferred to the relevant Parish Councils for their 'meaningful proportion' of CIL receipts. More detail on this is included in the 'neighbourhood CIL expenditure' section (from 2.3.4 below) and
  - £23,633.56 has been collected for use on the District Councils administrative expenses. More detail on this is included in the 'CIL administration' section (from 2.14).
  - £100,000.00 of Strategic CIL was transferred to Chasetown Football Club for a 3G/4G sports pitch.

- 2.8 This results in £339,283.90 of the CIL monies collected in 2023/24 being retained for spending on strategic infrastructure. An additional £477,610.88 was carried over from previous financial years for strategic infrastructure.
- 2.9 Between 13<sup>th</sup> June 2016 and 31<sup>st</sup> March 2024, £3,321,537.38 was collected for spending on strategic infrastructure. Of this, £2,129,000.00 has been allocated and £375,642.60 has been spent on strategic infrastructure projects (see Tables 2.5 and 2.6). Therefore, £816,894.78 remains unallocated for strategic CIL spending at 31<sup>st</sup> March 2024.

## Neighbourhood CIL

- 2.10 The District Council is required to pass on a proportion of CIL receipts to Parish Councils (this is known as the 'meaningful' or 'neighbourhood' portion). The neighbourhood portion is capped at 15% but rises to 25% in areas where a neighbourhood plan has been adopted. It will be for individual Parish Councils to determine how their portion of CIL receipts is spent. The neighbourhood portion of the levy must be spent on the provision, improvement, replacement, operation or maintenance of infrastructure; or anything else that is concerned with addressing the demands that development places on an area.
- 2.11 Neighbourhood plans are formal planning documents that local communities can prepare to guide the future development of their areas. There are currently a number of neighbourhood plans at varying stages of progression in the district. A total of 13 parishes have <u>adopted neighbourhood plans</u>.
- 2.12 Table 2.4 (below) demonstrates the receipt of Neighbourhood CIL monies in between 1 April 2023 and 31 March 2024.

2.13 Each year when they have received CIL funds, each parish and/or town Council must provide the required information relating to CIL spends and send a copy to the Council no later than 31 December following the reporting year. Once information on spend is received from the parish and town councils, the District Council will publish an addendum to the IFS setting out all the parish and town spend for the preceding financial year.

## CIL administration

- 2.14 CIL Regulation 61 states that a Charging Authority can collect 5% of CIL collected from year four onwards for administration. In 2023/2024, £472,671.29 was collected in CIL receipts, meaning that £23,633.56 is available for use in supporting CIL administration<sup>7</sup>. These funds will be spent on the management, staffing, administration, information technology and legal costs involved in:
  - The collection of CIL
  - The setting up and maintenance of new systems to coordinate the administration of CIL and
  - The ongoing management and oversight of CIL allocation and spending.

## Strategic CIL spending and allocation of monies

- 2.15 As detailed at paragraph 2.8 at the 31 March 2024 £816,894.78 of Strategic CIL monies remained unallocated. This included an additional £477,610.88 carried over from previous financial years for strategic infrastructure, in addition to the £339,283.90 of strategic CIL collected in 2023-2024. £0 was allocated for spending on strategic infrastructure within the reporting year.
- 2.16 Tables 2.5 and 2.6 detail the expenditure including allocations of strategic CIL funds within the reporting year. Table 2.5 shows that no projects were allocated monies within the reporting year. Table 2.6 shows the expenditure of strategic CIL funds which had been allocated in previous reporting years.

Strategic CIL project withdrawals

2.18 In cases where grant funding agreements expire before project completion, or the conditions outlined in Cabinet reports are not met within reasonable timeframes, the District Council reserves the right to withdraw support and funding from these projects. This allows the funds to be returned to the Strategic CIL pot for reallocation. Table 2.7 lists two projects that have lost Strategic CIL funding in 2023/24.

#### Infrastructure List

- 2.19 The Infrastructure List (IL) sets out the infrastructure projects or types of infrastructure which the Council intends will be, or may be, wholly or partly funded by CIL. Strategic CIL money collected can only be allocated and spent on these types of infrastructure.
- 2.20 The IL will be reviewed annually by the Strategic Infrastructure Group (SIG) and Overview & Scrutiny Committee prior to approval by Cabinet, in line with the approved CIL governance arrangements. The IL will reflect priorities identified in the Infrastructure Delivery Plan (IDP), emerging Local Plan and Lichfield District 2050 Strategy.
- 2.21 The inclusion of a project or type of infrastructure on this list does not signify a commitment from the Council to fund (either in whole or in part) the listed project or type of infrastructure through CIL.
- 2.22 Infrastructure providers that are responsible for projects identified within the IL will formally bid for the release of funds from this centralised strategic pot via a formal application process to assist in delivering the infrastructure detailed within the Infrastructure List. The onus will be on applicants to produce strong evidence-based arguments, which will include clear delivery plans for proposed projects along with potential and secured match funding information.
- 2.23 The following are the key types of infrastructure that the District Council will seek to fund (wholly or in part) through CIL in future reporting years. Extensive discussion has taken place between officers, members and stakeholders to set the priorities of this list which will inform the formal application process taking place in Autumn 2024 after the report as been through the cabinet process.

2.24 Further detail in respect of the priorities for infrastructure in future years is included at section 4 of the report.

## 3. Section 106

- 3.1 The <u>adopted Local Plan</u> includes policies which enable the authority to seek planning obligations through Section 106 (S106) agreements to deliver infrastructure to meet the priorities in the Local Plan. Examples of types of infrastructure secured in this way are affordable housing, public transport improvements, tackling climate change (e.g. flood risk management) and the provision of education, health and childcare facilities.
- 3.2 Section 106 agreements are legal agreements negotiated between the Council and other relevant parties as part of the planning process. The planning obligations included in a S106 agreement must relate to the development and are required to make the development acceptable in planning terms. Unlike CIL, S106 agreements are subject to negotiation and as such the priorities for differing types of infrastructure will sometimes pull in differing directions. S106 obligations will not solely be financial, as they can also relate to the delivery of specific infrastructure for example; affordable homes, schools, open space and transport infrastructure.
- 3.3 The following section details the S106 obligations agreed and received within the reporting year.

## Section 106 agreements signed

- 3.4 Developments with notable S106 agreements signed in the last financial year (2023/24) are in table 3.1, with potential financial obligations due to the District Council totaling £920,787.38.
- 3.5 Staffordshire County Council are the Education and Highways Authority for Lichfield District and therefore the obligations are not collected by the District Council. Similarly, any healthcare contributions are collected by the District Council but are transferred to the Integrated Care Board for Staffordshire and Stoke on Trent.
- 3.6 S106 agreements and other relevant documentations from each planning application can be viewed online on <u>our planning portal</u>.

3.9 In 2023/24, £516,308.11 of Section 106 funds were spent. This spending of S106 monies consisted of contributions to the Cannock Chase SAC to mitigate the impact of development, ecology, open space and social and community schemes.

## Cannock Chase SAC

3.10 Where a development is non CIL-liable or exempt from CIL, planning obligations are secured to mitigate for the harm of the development on the Cannock Chase SAC through a S106 agreement. Contributions received will be spent on projects to mitigate the harm on the SAC in accordance with adopted Local Plan policy. The total of such contributions spent within the reporting year was £21,239.58.

## Social and community

3.11 As detailed in Table 3.4 there has been an expenditure of £152,072.10 on social and community projects within the reporting year. These include expenditure on a new community centre in Streethay, car park variable message signing in Lichfield and a new electrical heating system at St Stephens Church, Fradley.

## Housing

3.12 Section 106 funds are drawn down and the various contributions are allocated to relevant projects at the end of each financial year. There was £0 of S106 housing spend within the reporting year.

## Education

3.13 S106 contributions (both financial and non-financial) for education infrastructure are collected and allocated to specific projects as advised by the education authority Staffordshire County Council. These planning obligations will be defined within the respective S106 agreements. Expenditure and further details on education contributions received and projects funded within the district can be seen within <u>Staffordshire County</u> <u>Council's IFS</u>.

## Transport

3.14 S106 contributions (both financial and non-financial) for transport infrastructure are collected and allocated to projects as advised by the highways authority including those contributions made under Section 278 of the Highways Act. Expenditure and further details

on transport contributions received and projects funded within the district can be seen within <u>Staffordshire County Council's IFS</u>.

#### Parks and open spaces

3.15 Section 106 agreements are used to deliver open space on site (or within an appropriate location within close proximity of a development) or a financial contribution to enable delivery. In the 2023/24 financial year £0 of S106 monies were spent on the ongoing maintenance of Public Open Space.

#### Current section 106 balances

- 3.16 The section 106 balance at 31 March 2024 was £4,342,325.68. Of this:
  - £2,195,315.10 is allocated to specific projects, £542,120.15 is allocated for the purposes of longer-term maintenance of open space (commuted sums), £71,011.07 is allocated towards the Cannock Chase SAC and £573,364.53 is retained for the purposes of ecological mitigation; and
  - £960,514.83 in S106 funds remain committed towards future projects, which will need to meet the specified requirements defined within the section 106 agreement relating to each site.

# 4. Planned expenditure

- 4.1 This section sets out how CIL and S106 income will be spent over the next reporting period in Lichfield district (as per the requirements set out in relevant planning practice guidance and the CIL regulations).
- 4.2 The level and timing of CIL funding will depend on the nature and scale of the development, the number of implemented planning permissions, build-out rates, and the phasing of development etc. Due to the uncertainty over forecasting, the amount of CIL funding will be based on the total receipts collected from the previous financial year and any unspent receipts from previous financial years.
- 4.3 S106 financial obligations must be spent in accordance with the terms of the legal agreement (as part of the planning application process). In respect of non-financial planning obligations secured through S106 agreements, the delivery of these items is intrinsically linked to the requirements of a development site.
- 4.4 S106 income varies on a site-by-site basis depending on a range of factors, such as the viability of development and site-specific considerations. This makes it difficult to forecast future S106 income and expenditure.

## Strategic CIL future expenditure

- 4.5 In previous years the strategic CIL allocation has been used to assist in the delivery of several projects per the Regulation 123 List. Due to changes in regulations CIL is no longer restricted to strategic infrastructure projects identified in the Regulation 123 List.
- 4.6 CIL receipts will also be made available through the capital programme to spend, in whole or in part, on the items of infrastructure which are referenced in paragraph 2.18 of this report.
- 4.7 As part of the Strategic Infrastructure Group priorities have been identified from 2.18 with healthcare provision, transport infrastructure, environment and biodiversity and low carbon initiatives being highlighted as the four main priorities for any investment in the coming financial year.
- 4.8 It should be made clear that CIL monies should not be seen as a substitute for appropriate budget setting on infrastructure projects by relevant authorities tasked with providing strategic infrastructure, which would be outlined within the councils Infrastructure Delivery Plan. There should be an open approach allowing for applications from a range of potential stakeholders to be eligible for funding and for elected members to ultimately determine how the funds could be allocated through an application process.
- 4.9 There will be regular opportunities for infrastructure providers, local community groups and stakeholders to put forward proposed projects and make bids for funds and projects will decided through the approved assessment process. Where possible, projects will be expected to show an element of match funding.

#### Neighbourhood CIL future expenditure

- 4.10 The District's Neighbourhood CIL Fund will be used to help deliver a wide range of projects at the local level for example:
  - Improvements to streets and local green spaces
  - Improvements to local community facilities
  - Local education infrastructure
  - Community safety measures
  - New health and social care facilities
  - Green and blue infrastructure.
- 4.11 Parish and Town Councils can spend their portion of CIL on a wider range of things (other than infrastructure) than the rest of the levy, provided that they meet the requirement to 'support the development of the area' within the regulations.

#### Section 106 future expenditure and delivery

- 4.12 There is approximately £3,381,810.85 of planned expenditure in place, with further plans to increase allocations of unallocated monies towards future spending over the next financial year and beyond.
- 4.13 Details of planned S106 expenditure across each main spend area can be seen in Table 3.5. Much of our planned spending is focused on the development of new and improved social and community infrastructure, for example:
  - New leisure centre in Lichfield
  - New community centre in Streethay
  - Skateboard park at Burntwood Leisure Centre
- 4.14 In terms of the unallocated remaining balance, careful consideration will be given to how to allocate monies according to the legal definition within the corresponding S106 agreements as well as the wider funding and policy context.
- 4.15 With regards to the future delivery of non-financial planning obligations secured through S106 agreements these will be delivered in accordance with the terms of the respective legal agreements and reported where relevant in future versions of the IFS.

## 5. Conclusion

- 5.1 Lichfield District Council is committed to working with its partners to ensure that CIL and S106 contributions are used in a fair and transparent way to maximize the benefits and opportunities arising from development.
