



Mavesyn Ridware neighbourhood plan information statement

A referendum relating to the Mavesyn Ridware neighbourhood Plan will be held on 13 February 2025.

The question which will be asked in the referendum will be:

'Do you want Lichfield District Council to use the Neighbourhood Plan for Mavesyn Ridware to help it decide planning applications in the neighbourhood area?'

The referendum area is identified on the map which is included with this statement. The Referendum area is identical to the area which has been designated as the Mavesyn Ridware neighbourhood plan area.

A person is entitled to vote in the referendum if on 13 February 2025:

- (a) He or she is entitled to vote in a local government election of any Councillor in the Referendum area; and
- (b) his or her qualifying address for the election is in the Referendum area. A persons qualifying address is, in relation to a person registered in the register of electors, the address in respect of which he or she is entitled to be registered.

The referendum expenses limit that will apply in relation to the referendum is £2421. The number of persons entitled to vote in the referendum by reference to which that limit has been calculated is 1004.

The referendum will be conducted in accordance with procedures which are similar to those used at local government elections.

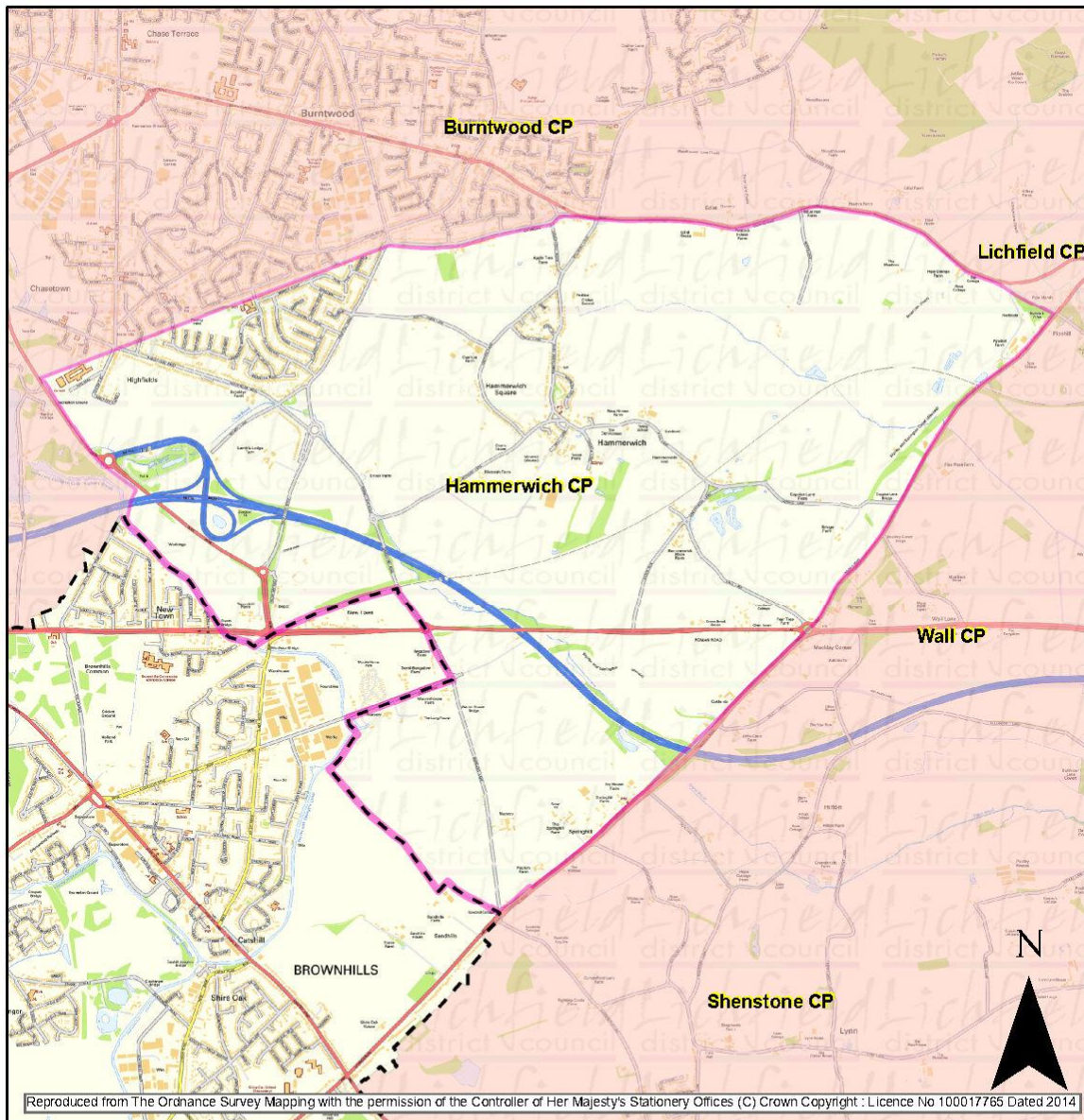
